Key indicator 1: The engagement of all students in regular physical activity

To maximise access for primary aged students to regular sporting and adventurous activities (in addition to: Timetabled PE, 120 minutes per week; plus social play 15 minutes x5 and 20 minutes x5 = 145 minutes per week). Key indicator 3: Increased knowledge, confidence and skills of key staff in teaching PE and Sport

PE Lead to plan the curriculum, and guide and instruct support staff in leading sports beyond football, such as tag rugby, cricket, rounders and badminton. New PE lead from September 2022 to receive support and advice from Lead Teacher, and to observe good practice in other schools.

Evaluation and Plan for 2023-24

Sports and PE Premium is allocated based on the number of eligible students on roll at a single point in the preceding academic year, namely the January census. Due to the high turnover of students, which is an intrinsic part of the work of an AP Academy, this does not reflect the number of eligible students on roll in the course of the ensuing academic year. This is compounded by the fact that many of our students are dual registered, so the PE and Sports Premium will be allocated to their mainstream school rather than Chalk Hill. The complex way in which mainstream schools receive this Premium makes it difficult for us to claim back an agreed sum for dual registered students.

Once funding has been secured we plan to use it to support the activities outlined above that were planned, went ahead successfully, and will be repeated in 2023-24, as well as extending plans as indicated in the *sustainability* column above.
